- VI. REPORTS: Reports will be brief.
a. Germaine Simenson, Council Delegate/Legislative Assistant, Tia Silver: It was suggested that we remove going forward due to never showing up. This shows verification that they never showed up to any of the meetings we have set thus far.
b. Commander, Richard Claw: Is our organization important? When Mr. Harrison Honie started the Black Mesa Chapter Veterans Organization, the way he thought of the organization, he started the process to get it up and run as an organization. When he stepped down, he told the organization to never let anyone, or anything, disperse from the organization. The organization remains to this day. The request for funding of \$500,000, for the veterans building has moved to Mr. Browns desk. Commander suggested that he and CLUP-C (Dorothy Yazzie) go in person to see Mr. Myron Tsosie or Mr. Brown regarding the proposal. Those requesting the Chapter Housing Discretionary funds need to come before the Chapter Officials during official Chapter Meeting to request the funding. Some families within the community have requested a family plot due to no more space within their current burial grounds. Edbert Little has now been approved to be a check signor for Black Mesa Chapter. Princess pageant was a success with Don, Ray, Candace, Clark, Freddie, and Richard Claw in attendance to post colors. ARPA Funds need to be used up within 13 months. There is \$370 million still available. Currently there are 425,042 registered Navajos within the Navajo Nation. President Nygren suggested to issue hardship checks. Controller Sean McCable suggested halting all projects and getting more funding for hardships. President Nygren and



Speaker Curley are still in court proceedings. Judge may say Nygren has the authority to fire the Controller or not. Black Mesa Veterans Organization has turned in all budget, Plan of Operation and approved Officers. President Nygren has been signing Proclamation for Purple Heart Community for various chapter houses. Community members suggested that ARPA Hardship funding should have all veterans included.

- c. Vice-Commander, Wilson Honie: Family honored Veterans Day and Thanksgiving Day with a dinner and family get together. A tradition that Mr. Honie's mother started and to this day the event continues. Advised fellow comrades to prepare for winter. Updated CLUP-C progress with the rural road addressing. Road signs have arrived and are currently stored at Black Mesa Chapters warehouse. CLUP-C ordered equipment and tools that will be needed to put up the road signs. Projected date to start will be when weather warms up due to road conditions. They still need to hire and have in-service safety training with the employees.
