 - a. Germaine Simenson, Council Delegate/Legislative Assistant, Tia Silver: No Show
 - b. Commander, Richard Claw: Made report regarding the August 2025 Black Mesa Chapter Meeting minutes. Current veteran count for BMVO is 18 men, 8 women and 3 surviving spouses with a total of 29. Initially we have 30 veterans within our organization with 5 high risks, 3 surviving spouses. CNVO has 26 veterans registered with 4 that have not updated registration. Veterans Trust Fund was to be raised from 4% to add 8% but after reviewing it was noted that veteran funds would deplete faster so it was stated that if we do 4% to 6% it would be better. It’s currently still on the table for discussion.
 - c. Vice-Commander, Wilson Honie: Reported on the road conditions during the time that the CNVO meeting was to occur at the Black Mesa Chapter House. Also it was reported that

CLUP-C ordered the road signs and once they come in, they will hire personnel to put them up along the roadways.

VII. OLD BUSINESS:

- a. Update of Veterans Facility: Dorothy Yazzie updated that all documents were mailed to Myron Tsosie. \$500,000 was given for the designs but only \$200,000 was used, therefore the remaining balance will be used for the construction. Many attempts have been made to Mr. Tsosie but unable to reach him. Left numerous messages with his assistant. Over \$1 million is needed to start the construction. Attempted to follow up with State Representative but they only work 6 to 7 months out of the year. Over 500 million is in the Si'Hasiin fund, but no new projects are moving forward due to unfinished projects.
- b. Update Veterans Trust Fund: Stipends for CNVO meetings was changed from 12 months to 6 months so adjustment in the allocation budget has changed. Self Help was changed to \$7213.00 (7 x \$900.00 and 1 x 913.00), Medical changed to \$1,650.00 (11 x \$150.00) one time assistance, and Stipend changed to \$3,600.00 (12 x \$75.00 and 6 x \$150.00)
- c. Chapter *Permanent Veterans Funds*' current total balance is \$3,679.63.
Discussion was made to transfer veterans' funds to new construction of veterans building. The commander stated that he would look into it.
Another discussion was made to also have the CNVO monthly meetings to be centralized back to Chinle instead of going from Chapter to Chapter.
