  - A. Local: Commander Dedman did not have much report locally. He told the members that there some veterans who have not applied for 2<sup>nd</sup> round of assistance yet. If there is some left after everybody got the 2<sup>nd</sup> one, we need to discuss how we are going to use it probably at the next meeting.
  - B. Agency: He told the members that he attended a special Agency meeting on January 13, 2026. It was about having to replace Tim Johnson, who was appointed to be NN President's Liaison. Mr. Harrison Kee from Pinon, AZ was selected to be the new Agency Commander. There was a regular Agency meeting on January 30, 2026 in Many Farms, AZ. We were told to keep working on Veteran count and use all the VTF that was allocated for each Chapter. They said use it all. Plans to update VTF Policy & Procedure in rough draft, should have them available at our next meeting, to review it. There is also an update on the housing project.
  - C. Financial: Commander Dedman told the members about how much is still available for assistance, which is only Hardship and Energy. As of January 14, 2026, Hardship still has \$2,663.50 and Energy has the same amount. Officers' stipend is at \$2,400. Also the Chapter fund is at \$4,997.65.
