MEETING MINUTES

SATURDAY February 14, 2026

BAAHAALI CHAPTER HOUSE

Meeting was Called to Order at 0930 am and 6 Veterans/Spouses/1 guest present. Invocation and Pledge of Allegiance was done.

Adoption of Agenda was approved motion by Jimmie Willie. 2nd by Alyce Skeets Vote: In favor 5, Opposed 0, and Obtained 2.

Reading and accepting the minutes of January 10, 2026. Motion to accept the minutes as is made by Alyce Skeets, 2nd by jimmie Willie. No questions or discussion. Vote: in Favor 5, opposed 0, and abstained 2

1. Commander's report: Baahaali Commander reported ENAVO meeting on February 11, 2026
 - a. Ms Shelby Vandever reported status of ENAVO funding balance. Baahaali Veterans Organization total is now 34, double the members. They are still focusing on updating and accepting registration. On Feb. 13, 2026, NNVA is sponsoring new homes construction application drive at Standing Rock Chapter House. Housing Specialist resigned from her position.
 - b. Tim Johnson appointed president's liaison introduce himself with his duties and responsibilities.
 - c. Harry Garcia talked about his views on veterans at state level.
 - d. 3 resolutions were presented and voted on:
 - i. ENAVO Resolution-26-005 SUPPORTING IMPLEMENTATION OF CJY-46-98 AND OPPOSING UNAUTHORIZED RESTRICTONS ON VETERAN TRUST FUND HOME IMPROVEMENT ASSISTANCE Vote: 16 in favor, 1 opposed and 6 abstained.
 - ii. ENAVO Resolution-06-26 A RESOLUTION OF THE ENAVO REQUESTING THE NNVA TO PROVIDE CURRENT BALANCES OF THE VTF AND GF, UPDATED MEMBERSHIP COUNTS FOR ENAVO AND REQUESTING NN COUNCIL TO APPROPRIATE ADDITIONAL FUNDS TO MEMEBERSHIP INCREASE. Vote 23 in favor, 0 opposed and 4 abstained.
 - iii. ENAVO-26-007 STIPEND, basically having Quarterly ENAVO meeting and allowing funds to assist other veterans. Vote 11 in favor, 4 opposed and 3 abstained. Baahaali Commander voted OPPOSED.
2. Old Business; Gift/Awards. Jackets will have Baahaali Veterans Organization with branch of service on back and US flag on left sleeve. All the same design. Any other patterns, names, emblems will be at your expense. Also need 2 more quotes to comply with NN Budget Policy.
3. New Business: NNVTF balance \$1281.00, \$400 in Hardship which needs to be transferred to either programs or stipend. Will make decision at next meeting March 14th.
