Regular Meeting Minutes
FEBRUARY 17, 2026



- I. **Meeting called to order:** Regular meeting of B/PVO was called to order at 10:35am, February 17, 2026, by Commander Hoskie Kee, A quorum was present.
- II. **Pledge of Allegiance:** was recited by members.
- III. **Order of business:** Accepted agenda as presented. Agenda adopted. Motioned by Herman Begay, 2nd by Mary Gaytan with a vote of 8 in favor, 0 opposed, and 3 abstentions
- IV. **Minutes of previous meeting:** Meeting of January 20, 2026, minutes was read and approved. Motion by Mary Gaytan, 2nd by Melton Martinez. Approved with a vote of 7 in favor, 0 opposed, 3 abstentions.

V. Reports:

Harry Garcia: Stated that he is candidate for NM House of Representative District 69. Claim that there is no representation of veterans at state level where there is only one representative in the House that is a Veteran. State needs to be more involved with Navajo Nation, especially mental health of veterans and housing needs. I would appreciate support this coming June and I will have an open-door policy. When he was there, he was Chair of Veterans Committee. Brought refreshments.

Financial reports: Commander handed out written financial report as of February 12, 2026. (report attached) The Trust Fund has program funds available for usage. General Fund has a balance of \$4,139.14. Form 105 and annual registration form can also be emailed. Chapter fund16 is available for catering and awards.

Newly amended Veterans Act recognizing CVO and Agency Organization states that there shall be one vote per CVO at Agency meetings. Also, Director is not a member of the advisory council but must attend advisory meetings and do a report. The advisory is now charged with advising the director and the President.

The Agency Council of Chapter officers held a special meeting at Iyanbito Saturday where NN Controller stated that there are a lot of ARPA funds that are still available. There is about \$700M that was not encumbered but \$512M had been funded with the Revenue Replacement Reserve Fund. Controller also stated that about \$550M may be available for hardship assistance but not all will receive that assistance due to new

requirements from federal. The new requirement is that individuals must qualify for assistance and NN is still working on the policy.

Priority may be for low-income families, elderly, and hopefully veterans. Lori John, VSO is a certified VSO with the ability to help any veteran to submit for benefits and compensation. Schedule a time to speak with her or to update your application.


