SPECIAL MEETING MINUTES

IYANBITO VETERANS ORGANIZATION (IVO)

Wednesday February 4th,2026 @ 1700 hrs.

1. Commander Eugene Marshall called the meeting to order at 1748 hours
Roll call by Secretary/Treasurer Eunice Skeet
Invocation by Veteran spouse Alice Collins
Pledge of Allegiance by all in attendance
Moment of silence by all in attendance
2. Commander Marshall reviewed the meeting agenda. Motion to accept the agenda made by Cheryl Johnson and Second by Benjamin Smith. A vote was taken with 18 In Favor, 0 Opposed, and 4 Abstained.
3. New Business: **Line A: Budget Transfer:** Commander Marshall briefly explained the meeting topic and handed the floor over to our Eastern Agency VSO Lori John. VSO John explained to the veterans several options on how to effectively transfer the Veterans Trust Funds through Exhibits A through F. There was a lengthy and in-depth conversation on the topic. The Iyanbito Veterans agreed to transfer \$3,600.00 from Programs (7110) to Traditional Healing (6912) and \$1,200.00 from Programs (7110) to VA Transportation (8060) Leaving a balance of \$24.00 in Programs (7110). With these transfers the Iyanbito Veteran Organization will be able to assist 9 Veterans with Traditional Healing in the amount of \$400.00 each and 8 Veterans with VA Transportation in the amount of \$150.00 each. Veteran Crystal Jimson motioned to accept Budget Transfer and Veteran Cheryl Johnson second the motion. A vote was taken and was as follows: 21 In favor, 0 Opposed, and 3 Abstained.
4. **Line D:** Approval of stipends for the February 4th,2026 Special Meeting. Commander Eugene Marshall \$75.00 for Special Veterans Meeting, Vice-Commander Anson J. SPECIAL MEETING MINUTES

IYANBITO VETERANS ORGANIZATION (IVO)

Wednesday February 4th, 2026 @ 1700 hrs.

1. Commander Eugene Marshall called the meeting to order at 1748 hours
Roll call by Secretary/Treasurer Eunice Skeet
Invocation by Veteran spouse Alice Collins
Pledge of Allegiance by all in attendance
Moment of silence by all in attendance
2. Commander Marshall reviewed the meeting agenda. Motion to accept the agenda made by Cheryl Johnson and Second by Benjamin Smith. A vote was taken with 18 In Favor, 0 Opposed, and 4 Abstained.
3. Commander Marshall gave the floor to Secretary/Treasurer Eunice Skeet to read the Previous meeting minutes. A motion was made by Arnold Collins and Seconded by Cheryl Johnson. Commander Marshall gave the floor to the veterans for any questions or comments. Veteran Albert Shirley asked what the purpose of Commander Marshall's resignation was about. Commander Marshall stated that due to the veterans not attending the IVO meetings and not supporting him or the organization he feels that there really is no purpose to be in Command. The only time veterans attend meetings is when there are funds to give out. Commander Marshall needs the veterans support to be able to make changes for the better. Commander Marshall is looking for a replacement. He will not resign until there is a replacement. A vote was taken and was as follows: 14 In Favor, 0 Opposed and 2 Abstained.
4. Commander Marshall recognized Iyanbito Chapter CSC Delray Tom.
5. Commander Marshall reported that he could not make it to the ENAVO meeting, but he had Vice Commander Arviso attend in his place. He also stated that he called the Eastern Agency for some updates. He was told that the Veterans Organizations can do a budget transfer, veterans are eligible to request for assistance for a 2nd round and if there are no funds available in the Trust Fund that the General Funds will be utilized. Commander Marshall also mentioned if the Veterans Organization wants to change our IVO meetings from monthly to quarterly meetings it would have to be motioned and voted on. Commander Marshall read out a list of veterans who have not yet picked up their Veterans Day food vouchers and if any veterans see or know them to have them contact him. Commander Marshall gave the floor to the veterans for any questions or comments on his report. There was a lengthy discussion on the IVO meeting changes and Commander Marshall suggested that he will do further research on the topic and will inform at the next meeting. Vice-Commander Anson reported that Commander Marshall already gave the report that he had and that he also is going to resign due to his health condition and wants someone to step up and take the Vice Commander position. Secretary/Treasurer Eunice Skeet had no report but also stated that she wanted to resign as well. Iyanbito Chapter CSC Delray Tom reported that the regular chapter meeting will be on January 21st at 9 am. She also stated that there will be an appreciation luncheon for our former Council Delegate Steven Arviso. Mr. Arviso is also a Veteran and there for Ms. Tom requested if the IVO could assist with the main dish purchase utilizing Iyanbito Chapter Veterans Fund 16 account in the amount of \$180.00. A short discussion took place and Veteran Albert Shirley Motioned to add it to the agenda

under New Business line C and to change the original line C to line D. Veteran Arnold Collins second the motion. A discussion took place and the motioning parties who motioned to accept the agenda agreed with the add-on. A vote was taken and was as follows: 12 In Favor, 2 Opposed, and 2 Abstained.

6. There was no old business.

7. New Business: **Line A:** Budget Transfer: Commander Marshall read out the updated budget and asked how the veterans want to transfer the funds. **Vice Commander Arviso recommended to transfer from Programs (7110) \$2,400.00 to Hardship (8060), transfer \$2,400.00 from Programs (7110) to Energy (8065) leaving Programs (7110) with a balance of \$24.00. Also transferring \$1,000.00 from Self Help (8515) to Hardship (8060) and transferring \$1,000.00 from Self Help (8515) to Energy (8065). Leaving Self Help (8515) with a balance of \$00.00. Total in Hardship (8060) will be \$3,400.00 and Total in Energy (8065) will be \$3,400.00. Veteran Arnold Collins motioned to accept recommendations and Veteran Cheryl Johnson second the motion. A vote was taken and was as follows: 15 In favor, 0 Opposed, and 2 Abstained.**

New Business; **Line B:** Commander Marshall opened the floor for any financial requests. The following veterans requested assistance of \$400.00 from Hardship for food purchase and \$400.00 from Energy for fire wood purchase: Anson Arviso, Patrick Dennison, Arnold Collins, Janyce Francisco, Cheryl Johnson, Albert Shirley, Michael Sloan, Benjamine Smith, Tyrone Pablo, Arthur Frank, Toni Benally, Jenny Yazzie, Elisa Mark, Eunice Skeet, Eugene Marshall, Audra Arviso, Amera Sloan, Sean Yazzie, Vicky Hand, Anthony Shirley, Janice George, Evelyn Bartlett, Phillip Smith, Delbert Smith, Barbara Francisco, and Jones Padilla. There are 26 total veterans requesting assistance. Veteran Albert Shirley motioned to accept the requests followed by a second by Veteran Tyrone Pablo. A vote was taken and was as follows: 26 In Favor, 0 Opposed and 3 Abstained.

Line C: Iyanbito Chapter CSC Delray Tom requested for the IVO to help assist in purchasing the main dish for our former Council Delegate Steven Arviso's appreciation luncheon as Mr. Arviso is a Veteran and to utilize Iyanbito Chapter Veterans Fund 16 account in the amount of \$180.00. Veteran Bengamin Smith motioned to accept, followed by a second by veteran Arnold Collins. A vote was taken and was as follows: 13 In Favor, 2 Opposed and 14 Abstained.

Line D: Approval of stipends for the month of January 2026. Commander Eugene Marshall \$75.00 for local veterans meeting, Vice-Commander Anson J. Arviso \$150.00 for the ENAVO meeting and \$75.00 for local veterans meeting and Secretary/Treasurer Eunice Skeet \$75.00 for local veterans meeting. A motion to approve was made by Albert Shirley and Second by Cheryl Johnson. A Vote was taken and was as follows: 15 In Favor, 0 Opposed and 14 Abstained.
