Find a way to track who has submitted and who has not submitted. So, we don't shortchange veterans. We need to get better accountability from Crownpoint Veterans Office.

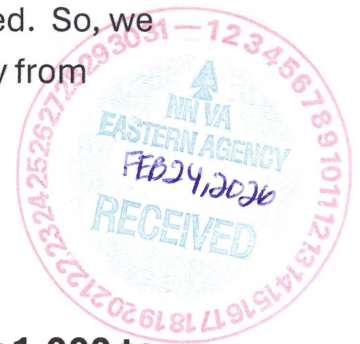
**Approve 6-0-1 Old Business**
