



## **NAVAJO NATION VETERANS ADMINISTRATION LOAN PROGRAM**

**Please ensure that the application is thoroughly completed, duly signed, and dated. Additionally, all requisite supporting documents must be attached. If you are currently married, your spouse must be included on the same application and provide the necessary documentation.**

- *DD-214 (Honorable Discharged) (Served 180 days)*  
Must be an enrolled member of the Navajo Nation.

### **Required Documents for all Applicants (If married, spouse must provide all required documents)**

- Two recent pay stubs, recent Monthly Bank statements.  
**Most recent statement, including all pages**
- Driver's License, Social Security Card, and Certificate of Indian Blood.  
**All credentials must match the exact name spelling shown on your Social Security Card. Applications with name discrepancies on other credentials will not be approved.**
- Fixed Income: Provide an award letter from Pension, Disability, Retirement, Etc.  
**Most recent award letter for benefits**
- Employment Verification: Completed by authorized Employer Personnel Official.
- Map to Resident and Work: Draw specific information, street name, street numbers, Road and Highway numbers.
- W-9 Tax Form

- Married Veterans: include marriage certificate
- Bank verification form or Direct deposit form (set up direct deposit requirement)

**Co-signer – Navajo Nation member**

- Two most recent pay stubs, recent Monthly Bank statements

- Driver's License, Social Security Card, and Certificate of Indian Blood.

I (We) understand, and I (We) agree to assume all financial and legal obligations arising from the granting of any credit made under the Veterans Loan Program. If applicable, I (we) understand that if I(we) am(are) an elected official or political appointee, a notarized Ethical Certification shall supplement the Application attesting that I(we) will refrain from requesting any special consideration from any personnel/program of the Navajo Nation government and will abide by the Navajo Ethics in Government Law. Any misstatement of fact(s) or misrepresentation of information may be grounds for ineligibility of this application.
