
RELATING TO GOVERNMENT SERVICES; CONCURRING WITH THE PRESIDENT'S ACCEPTANCE OF A MONETARY GIFT IN THE AMOUNT OF \$2,000 FROM ROSITA JUMBO HAYES FOR THE DEPARTMENT OF NAVAJO VETERANS AFFAIRS TO ASSIST ONE OR MORE INJURED NAVAJO VETERANS WHO HAVE RETURNED FROM IRAQ

BE IT ENACTED:

1. The Navajo Nation hereby concurs with the President's acceptance of a monetary gift in the amount of \$2,000 from Rosita Jumbo Hayes for the Department of Navajo Veterans Affairs to assist one or more injured Navajo veterans who have returned from Iraq. A copy of Ms. Hayes' letter and \$2,000 check, the President's letter of acceptance and related budget documents are attached hereto as Exhibit A.
2. This monetary gift in the amount of \$2,000 shall be deposited into an account within the Department of Navajo Veterans Affairs as designated by the Controller of the Navajo Nation, to be utilized in a manner beneficial to injured Diné veterans as expressed by the donor, and recorded with the Ethics and Rules Office, as required by 2 N.N.C. §§ 1010-1012.
