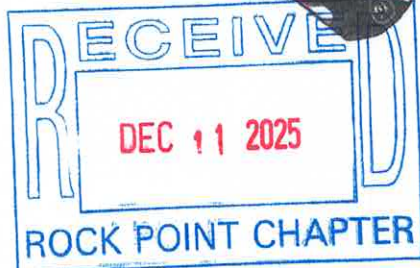

My report will be short and sweet. Happy Thanksgiving hopefully, you all had a good on the way you understand Thanksgiving. My family and I traveled to Mountain Home, Arkansas November 22 to the 29, is when we got home. We enjoyed our family get together. Our daughter "Evangeline" and her husband "Mark" are both Veterans, they live in Florida with our Granddaughter. Our son Darrell came as well with his family. We were all there during Christmas time last year too.
