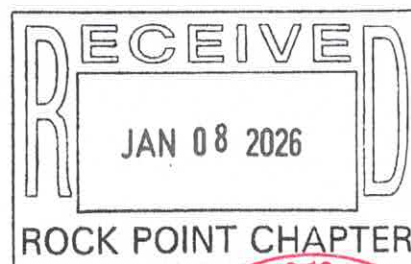

1. **Call meeting to order:** Meeting at 10:28 am January 06, 2026

4. **Roll Call:** Commander and Vice Commander were at the meeting along with the Secretary.
