MEETING CALLED TO ORDER AT 1800 PM BY COMMANDER RAMONE AND INVOCATION WAS GIVEN BY JENNIE YAZZIE. PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE WAS SAID BY ALL WHO WERE IN ATTENDANCE. MOTION TO REVIEW AND ADOPT AGENDA WAS MADE BY SAMPSON SIDAN SR. WITH A SECOND BY JENNIE YAZZIE AND A VOTE OF 15-1-0.
