A RESOLUTION RESTORING THE PER-ASSISTANCE CAP FOR HARDSHIP AND ENERGY ASSISTANCE TO THE ORIGINAL AMOUNT OF \$400.00

Tse Si Ani Chapter Veteran Organization

WHEREAS, the Tse Si Ani Chapter Veteran Organization provides Hardship and Energy Assistance to eligible veterans to address urgent and essential needs; and

WHEREAS, the Organization previously established a per-assistance cap of **\$400.00 per eligible veteran** for Hardship and Energy Assistance; and

WHEREAS, the Organization later adopted a temporary reduction setting the per-assistance cap at **\$253.00 per assistance** for Hardship and Energy Assistance; and

WHEREAS, the current cap of \$253.00 has proven insufficient to adequately meet the basic hardship and energy-related needs of eligible veterans due to rising costs and financial strain; and

WHEREAS, the Organization finds it necessary and appropriate to restore the per-assistance cap to its original amount in order to continue fulfilling its mission of supporting veterans in need;

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Tse Si Ani Chapter Veteran Organization hereby **restores the per-assistance cap for Hardship and Energy Assistance from \$253.00 back to the original amount of \$400.00 per eligible veteran.**
2. This restored cap shall apply to **both Hardship Assistance and Energy Assistance** provided by the Organization.
3. This adjustment shall be considered a **Second Quarter budget adjustment** and shall take effect **immediately upon adoption of this resolution**, unless otherwise specified by the Organization.
4. All prior policies, motions, or actions inconsistent with this resolution are hereby amended to reflect the restored \$400.00 cap.

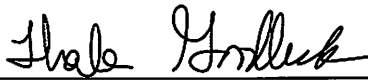
CERTIFICATION

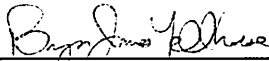

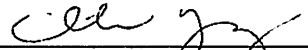
