WHEREAS:

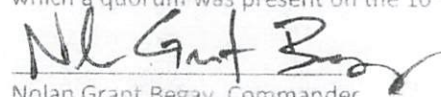

Nahata Dziil Commission Governance is certified by the Navajo Nation Council Resolution CAP-36-91 as a local governmental entity of the Navajo Nation government which has the responsibility and authority to promote, protect and preserve the interest and general welfare including the safety of its community, programs and property, etc.; and
3. The Transportation and Community Development Committee of the Navajo Nation Council by Resolution TCDCAU-66-02, approved governance certification of the Nahata Dziil Chapter's Five Management System Policies and Procedures pursuant to 26 NNC Section 102(B), which permits the Nahata Dziil Chapter to exercise of land administration authority pursuant to 26 NNC Section 103 (D)(1); and
4. Nahata Dziil Chapter is a certified chapter that is recognized by the Navajo Nation Council, pursuant to 26 NNC Section 3, and pursuant 11 NNC Part 1 section 10, the Navajo Nation Council, pursuant to 26 NNC Section 3, and pursuant 11 NNC Part 1 Section 10, the Navajo Nation Council adopted the Navajo Nation Local Government Act which directs local Chapter to promote all matters that affect the local community members and to make appropriated decisions, recommendations, and advocate on their basis; and
5. Nahata Dziil Chapter converted it's government into the Nahata Dziil Commission Governance based on the voice of the people; and
6. Nahata Dziil Veteran Organization is requesting \$6,500.00 to be Carried Over into Fiscal Year 2026 pay Gifts and Awards for Veterans using GL Code 6620 in Fund 16; and
7. Nahata Dziil Veteran Organization is requesting \$5,173.10 to be Carried Over into Fiscal Year 2026 assist Veterans with Food Purchases using GL Code 6352 in Fund 16; and
8. Nahata Dziil Veteran Organization is requesting \$3,500.00 to be Carried Over into Fiscal Year 2026 assist Veterans with Other Supplies using GL Code 6390 in Fund 16; and
9. Combined total for the Carry Over shall be \$15,173.10

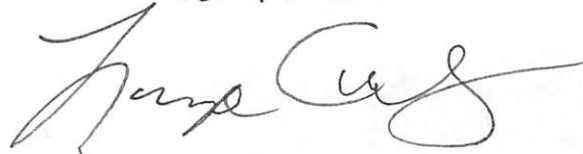

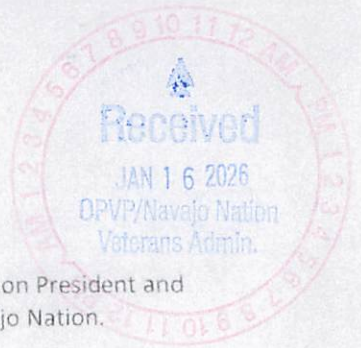
