**WHEREAS:**

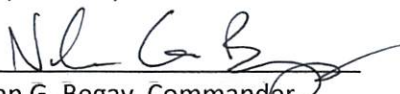

7. Nahata Dziil Veterans have since agreed to raise the amount, presented:

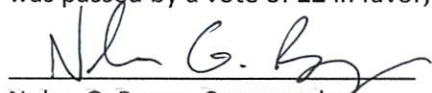
