- C. The NCGCVO requests that the Naschitti Community Governance continue providing Insurance Coverage under the Navajo Nation Risk Management; and
- D. The NCGCVO requests the Navajo Nation Department of Veterans Administration (NNDVA) to approve NCGCVO's FY2026 Budget for Fiscal Year 2026 for \$58,672.00; and
- E. It is in the best interest of the NNDVA to support and approve the requested NCGCVO Resolution to continue their duties to serve the membership of the Naschitti Community; and

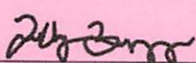
