RESOLUTION OF THE

Recommending to the Navajo Tribal Council, the Confirmation  
of the Appointment of Mr. Emmett Bia as a Member of the  
Veterans Committee of the Navajo Tribal Council

WHEREAS:


1. The Advisory Committee of the Navajo Tribal Council is the Executive Committee of the Navajo Tribal Council; and
2. Pursuant to 2 N.T.C. 1001(a), the Chairman of the Navajo Tribal Council has the authority to select members of the standing committees of the Navajo Tribal Council with the advice and consent of the Navajo Tribal Council; and
3. By Resolution CMA-17-89, the Navajo Tribal Council amended the Plan of Operation of the Veterans Committee of the Navajo Tribal Council which increased the membership from six (6) members to seven (7) members and caused a vacancy in the membership; and
4. The Interim Chairman of the Navajo Tribal Council has appointed Mr. Emmett Bia, Council Delegate from Chinle Agency, as a member of the Veterans Committee of the Navajo Tribal Council, attached hereto and incorporated herein as Exhibit "A"; and
5. The Advisory Committee of the Navajo Tribal Council herein acknowledges the appointment of Mr. Emmett Bia as a member of the Veterans Committee of the Navajo Tribal Council is in the best interest of the Navajo Nation.

NOW THEREFORE BE IT RESOLVED THAT:

The Advisory Committee of the Navajo Tribal Council hereby recommends to the Navajo Tribal Council, the confirmation of the appointment of Mr. Emmett Bia as a member of the Veterans Committee of the Navajo Tribal Council.
