WHEREAS, discharged Navajo veterans need lands on which they can develop farms and establish homes, and

WHEREAS, lands suitable for farming on the Navajo Reservation are extremely limited and are undeveloped at this time, and

WHEREAS, individual Indians, including veterans, are desirous of obtaining loans under the provisions of Part 26, Title 25, C. F. R., as amended April 13, 1944, and

WHEREAS, it is the opinion of the Navajo Tribal Council that credit to members of the Navajo Tribe should be conducted on an individual basis,

THEREFORE, BE IT RESOLVED, by the Navajo Tribal Council that the Federal Government is hereby respectfully requested to give every assistance to these veterans in acquiring farm lands wherever such Federally owned or controlled lands are available for settlement.

BE IT FURTHER RESOLVED, that the Navajo Tribal Council is not conducting credit operations under the provisions of Title 25, C. F. R., and declines to conduct such operations, and recommends that credit to Navajo Indians be extended by direct loans by the United States to individual Indians, with preference to veterans.
